RESOLUTION

**RECOMMENDING THE AWARD OF CONTRACT TO THE PHILIPPINE
INTERNATIONAL CONVENTION CENTER (PICC) FOR THE CONDUCT OF
TECHNICAL WORKING GROUP MEETING: "WRITESHOP ON THE REVISION
OF THE AO35 OPERATIONAL GUIDELINES TO BE HELD ON 24-26
SEPTEMBER 2019**

WHEREAS, there is a need for a venue for the conduct of the Technical Working Group Meeting, entitled: "Writeshop on the Revision of the AO35 Operational Guidelines" to be held on 24-26 September 2019;

WHEREAS, the procurement for the lease of venue for the said event is included in the CY 2019 Supplemental Annual Procurement Plan No. 3 with an allotted budget of One Million Three Hundred Thousand Pesos(P1,300,000.00);

WHEREAS, pursuant to the 2016 Revised Implementing Rules and Regulations of R.A. No. 9184, it is the policy of the government to give preference to publicly-owned real property or venue over privately-owned real property or venue, insofar as the lease of real property or venue for official use is concerned¹;

WHEREAS, the PICC is a government-owned institution, constructed pursuant to Presidential Decree No. 520 (s. 1974), as amended, as an international conference center suitable for the holding of international conferences, meetings, and similar undertakings;

WHEREAS, based on the aggregate charges sheet submitted by PICC, the total cost of lease of venue for the said activity including the meeting room and meals is Three Hundred Seventy-Three Thousand Pesos (P373,000.00);

NOW THEREFORE, for and in consideration of the foregoing premises, the Department of Justice – Bids and Awards Committee **RESOLVES**, as it hereby resolve, to **RECOMMEND** the award of contract to **PICC**, for the conduct of the Technical Working Group Meeting: "Writeshop on the Revision of the AO35 Operational Guidelines to be held on 24-26 September 2019, in the amount of Three
