RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT TO PHILIPPINE INTERNATIONAL CONVENTION CENTER (PICC) FOR THE CONDUCT OF THE 48TH REGULAR COUNCIL MEETING OF THE INTER-AGENCY COUNCIL AGAINST TRAFFICKING (IACAT) TO BE HELD ON 3 OCTOBER 2019

WHEREAS, there is a need for a venue for the conduct of the 48th Regular Council Meeting of IACAT to be held on 3 October 2019;

WHEREAS, the procurement for the lease of venue for the said event is included in the CY 2019 Supplemental Annual Procurement Plan 3 (SAPP 3) with an allotted budget of Five Hundred Forty-Three Thousand Pesos (P543,000.00);

WHEREAS, pursuant to the 2016 Revised Implementing Rules and Regulations of R.A. No. 9184, it is the policy of the government to give preference to publicly-owned real property or venue over privately-owned real property or venue, insofar as the lease of real property or venue for official use is concerned¹;

WHEREAS, PICC is a government-owned institution, constructed pursuant to Presidential Decree No. 520 (s. 1974), as amended, as an international conference center suitable for the holding of international conferences, meetings, and similar undertakings;


WHEREAS, based on the aggregate charges sheet submitted by PICC, the total cost of lease of venue for the said activity including the meeting room and meals is Ninety-Six Thousand Pesos (P96,000.00);

NOW THEREFORE, for and in consideration of the foregoing premises, the Department of Justice – Bids and Awards Committee **RESOLVES**, as it hereby resolve, to **RECOMMEND** the award of contract to **PICC**, for the conduct of the 48th Regular Council Meeting of IACAT to be held on 3 October 2019, in the amount of Ninety-Six Thousand Pesos (P96,000.00), following the procedures prescribed in R.A. No. 9184 and its 2016 Revised Implementing Rules and Regulations.
