RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT TO THE PHILIPPINE JUDICIAL ACADEMY FOR THE CONDUCT OF THE PROSECUTION CASE MANAGEMENT SYSTEM REPORTING MODULE WORKSHOP OF THE MANAGEMENT INFORMATION SYSTEM DIVISION TO BE HELD ON 23-25 OCTOBER 2019

WHEREAS, there is a need for a venue for the conduct of the Prosecution Case Management System (PCMS) Reporting Module Workshop of the Management Information Systems Division (MISD) to be held on 23-25 October 2019;

WHEREAS, the procurement for the lease of venue for the said event is included in the CY 2019 Supplemental Annual Procurement Plan No. 1 (SAPP 1), with an allotted budget of One Million Two Hundred Twenty-Four Thousand Three Hundred Eighteen Pesos and 30/100 (P1,224,318.30);

WHEREAS, pursuant to the 2016 Revised Implementing Rules and Regulations of R.A. No. 9184, it is the policy of the government to give preference to publicly-owned real property or venue over privately-owned real property or venue, insofar as the lease of real property or venue for official use is concerned¹;

WHEREAS, the Philippine Judicial Academy (PHILJA) is a government-owned facility, established by virtue of Republic Act No. 8557, has the mandate to deliver/provide the goods/services that complies with all the required general conditions provided for in R.A. No. 9184 on Agency-to-Agency Agreement;

WHEREAS, in a Certification submitted by PHILJA Chancellor Justice Adolfo S. Azcuna, it states that the PHILJA Training Center facilities may be used for the Training Programs and Seminars of Government Institutions outside the Judiciary, as indicated in the Guidelines for the Operations and Management of the PHILJA;

WHEREAS, based on the proposal dated 27 September 2019 submitted by PHILJA, the total cost of lease of venue, including the function room for the said activity, is Thirty-Two Thousand Four Hundred Pesos (₱32,400.00);

NOW THEREFORE, for and in consideration of the foregoing premises, the Department of Justice – Bids and Awards Committee **RESOLVES**, as it hereby resolve, to **RECOMMEND** the award of contract to PHILJA, for the conduct of the PCMS Reporting Module Workshop of MISD to be held on 23-25 October 2019, in the amount of Thirty-Two Thousand Four Hundred Pesos (₱32,400.00), following the procedures prescribed in R.A. No. 9184 and its 2016 Revised Implementing Rules and Regulations.


