## **RESOLUTION**

### **RECOMMENDING THE AWARD OF CONTRACT TO LEDPRO FOR THE LED WALL RENTAL, SOUND SYSTEM, BACKLINE SET-UP, PHOTOGRAPHY AND VIDEOGRAPHY SERVICES IN CONNECTION WITH THE 122<sup>ND</sup> FOUNDING ANNIVERSARY OF THE DEPARTMENT OF JUSTICE**

**WHEREAS**, there is a need for Led Wall Rental, Sound System, Backline Set-up, Photography, and Videography services, in connection with the 122<sup>nd</sup> Founding Anniversary of the Department of Justice (DOJ);

**WHEREAS**, the purchase of the aforementioned procurement is included in the approved CY 2019 Annual Procurement Plan (APP);

**WHEREAS**, the Approved Budget for the Contract (ABC)t under Small Value Procurement is One Hundred Fifty Thousand Pesos (P150,000.00);

**WHEREAS**, the DOJ posted its Invitation to Bid/Request for Quotation for the purchase of the said service in the PhilGEPS, DOJ Website, and conspicuous place in the Department continuously for four (4) calendar days, and was sent to three (3) prospective service providers, namely: Ledpro, Adlights Incorporated, and Pro Event;

**WHEREAS**, in response to the said Invitation, three (3) prospective suppliers submitted their quotations, to wit,

**WHEREAS**, after review and evaluation, the DOJ BAC-TWG found that Ledpro is legally, financially, and technically capable to undertake the

said procurement, and for having submitted the second Lowest Calculated and Responsive Quotation (LCRQ);

**WHEREAS**, considering that the amount involved in the subject procurement is **ONE HUNDRED THIRTY-THREE THOUSAND PESOS (P133,000.00)**, an alternative mode of procurement is allowed by GPRA, provided, that the amount shall not exceed the thresholds prescribed in Annex "H" of the 2016 Revised Implementing Rules and Regulations;

**NOW THEREFORE**, for and in consideration of the foregoing premises, the Department of Justice – Bids and Awards Committee **RESOLVES**, as it hereby resolve, to **RECOMMEND** the approval of Small Value Procurement as an alternative mode of procurement, and the award of contract to **LEDPRO** for the Led Wall Rental, Sound System, Backline Set-up, Photography and Videography services in connection with the 122<sup>nd</sup> Founding Anniversary of DOJ in the amount of **ONE HUNDRED THIRTY-THREE THOUSAND PESOS (P133,000.00)**, following the procedures prescribed in R.A. No. 9184 and its 2016 Revised Implementing Rules and Regulations.
