RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT TO MAXCOR INTER-VENTURES CO. FOR THE LEASE OF DIGITAL FORENSIC SUITE FOR THE USE OF OFFICE OF THE CYBERCRIME

WHEREAS, there is an urgent need for the lease of digital forensic suite for the use of the Office of Cybercrime;

WHEREAS, the Department of Justice (DOJ) posted its Invitation to Bid for the aforesaid procurement in the PhilGEPS, DOJ Website, and conspicuous place in the DOJ for more than seven (7) calendar days starting 18 June 2019;

WHEREAS, the purchase of the aforementioned project is included in the approved Annual Procurement Plan (APP) for CY 2019;

WHEREAS, the Approved Budget for the Contract is Two Million Nine Hundred Thousand Pesos (P2,900,000.00);

WHEREAS, in response to the said invitation, only Maxcor Inter-Ventures Co. submitted its bid in a public bidding held on 9 July 2019, 2:00 p.m. at Room 315, 3rd Floor, Delas Alas Hall Building, DOJ Compound, Padre Faura Street, Ermita, Manila, with the following details;

WHEREAS, the aforesaid bid was referred to the DOJ Bids and Awards Committee-Technical Working Group (DOJ BAC-TWG) for evaluation and post-qualification with the following findings;

WHEREAS, the result of the evaluation of the DOJ BAC-TWG shows that Maxcor Inter-Ventures submitted the Single Calculated and Responsive Bid (SCRB);


