**BAC RESOLUTION RECOMMENDING THE AWARD OF CONTRACT FOR
LEASE OF VENUE WITH MEALS AND ACCOMMODATION FOR THE
CONDUCT OF CAPACITY BUILDING SEMINAR**

WHEREAS, included in the approved 2019 Supplemental Annual Procurement Plan of NPS-Region 1 is the Capacity Building Seminar with an approved budget for the contract of **Eighty Nine Thousand Six Hundred Pesos (P89, 600.00)** allocated for venue including meals and accommodation and shall be undertaken through Section 53.10 (Lease of Venue) of the Implementing Rules and Regulations of Republic Act No. 9184;

WHEREAS, on December 3, 2019, the Regional Prosecution Office I, through the Bids and Awards Committee (BAC), initiated the procurement activity by sending the Request for Quotation to 3 lessors, viz: (1) Casa San Miguel; (2) Carimex Inc/Canoe Beach Resort ; and (3); Capones Vista;

WHEREAS, in response to the invitation, only Carimex Inc/Canoe Beach Resort submitted their bid;

WHEREAS, Carimex Inc/Canoe Beach Resort underwent post-qualification and evaluation rating;

WHEREAS, upon careful review and evaluation, the BAC found the offer of Carimex Inc/Canoe Beach Resort responsive to the requirements of the end-user, and is legally, financially and technically capable to undertake the procurement;

NOW, THEREFORE, we the Members of the Bids and Awards Committee, hereby RESOLVE to recommend to the Head of the Procuring Entity the award of contract for lease of venue with meals and accommodation for the subject procurement in favor of Carimex Inc/Canoe Beach Resort for being the Single Calculated and Responsive Bidder with a contract price of **Eighty Nine Thousand Six Hundred Pesos (P89,600.00)**.
