## RESOLUTION

### RECOMMENDING THE AWARD OF CONTRACT TO REMAX INTERNATIONAL, INC. FOR THE PURCHASE OF 459 UNITS OF DESKTOP COMPUTERS

**WHEREAS**, there is a need for the purchase of 459 units of desktop computers;

**WHEREAS**, the DOJ posted its Invitation to Bid for the aforesaid purchase in the PhilGEPS, DOJ Website, and conspicuous place in the DOJ for more than seven (7) calendar days starting 20 November 2019;

**WHEREAS**, the purchase of the said items is included in the CY 2019 Supplemental Annual Procurement Plan No. 6 (SAPP 6) with a total allotted budget of Eighteen Million Pesos (P18,000,000.00);

**WHEREAS**, in response to the said invitation, four (4) prospective suppliers submitted their bids in a public bidding held on 11 December 2019, 1:00 p.m. at Room 315, 3<sup>rd</sup> Floor, Delas Alas Building, DOJ Compound, Padre Faura Street, Ermita, Manila, to wit,
