

RESOLUTION

RECOMMENDING THE APPROVAL OF PURCHASE ORDER NO. 2019-05 FOR THE PURCHASE OF VARIOUS OFFICE SUPPLIES FOR ORP- REGION IV

WHEREAS, there is an urgent need to purchase various office supplies for the use of National Prosecution Services- Region IV (NPS-Region IV);

WHEREAS, the NPS - Region IV posted its Invitation to Bid-Request for Quotation for the purchase of common office supplies for ORP - Region IV in the PhilGEPS, DOJ Website, bulletin boards of the Office of the Regional Prosecutor, Region IV continuously for four (4) calendar days and sent to three (3) prospective suppliers;

WHEREAS, the purchase of the aforementioned goods is included in the Annual Procurement Plan (APP) for CY 2019 of the Department of Justice;

WHEREAS, the Approved Budget for the Contract under Shopping - Section 52.1(b) is ₱ 120,854.00;

WHEREAS, the suppliers here under submitted their respective quotations to wit;

WHEREAS, the result of the evaluation by the BAC Secretariat/TWG shows that **BITSLINK INFORMATION TECHNOLOGY SOLUTIONS** has submitted the Lowest Calculated and Responsive Quotation (LCRQ);

WHEREAS, considering that the amount involved in the subject procurement is **ONE HUNDRED EIGHT THOUSAND FIFTY PESOS (₱ 108,050.00)**, an alternative mode of shopping under Section 52.1 (b) is allowed by GPRA, provided, that the amount shall not exceed the thresholds prescribed in Annex "H" of its implementing rules and regulations;

NOW, THEREFORE, for and in consideration of the foregoing, the Bids and Awards Committee resolves, as it hereby **RESOLVE**, to recommend the **APPROVAL** of the alternative method of shopping under Section 52.1 (b), and further recommends the approval of **Purchase Order No. 2019-05** dated **August 16, 2019**, in the amount of **ONE HUNDRED EIGHT THOUSAND FIFTY PESOS ONLY (₱108,050.00)**.

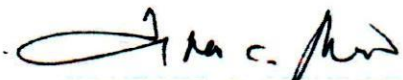
