RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT TO STANLEY BRADLEY TRADING, INC. (STANLEY BRADLEY) FOR THE PURCHASE OF CONSUMABLES FOR VARIOUS PRINTERS NOT AVAILABLE IN THE PROCUREMENT SERVICE

WHEREAS, there is a need for the purchase of consumables for various printers not available in the Procurement Service;

WHEREAS, the Department of Justice (DOJ) posted its Invitation to Bid for the aforesaid procurement in the PhilGEPS, DOJ Website, and conspicuous place in the DOJ for more than seven (7) calendar days starting 16 July 2019;

WHEREAS, the purchase of the aforementioned project is included in the approved Annual Procurement Plan (APP) for CY 2019;

WHEREAS, the Approved Budget for the Contract is One Million Seven Hundred Ninety Thousand Five Hundred Fifty Seven Pesos (P1,790,557.00);

WHEREAS, in response to the said invitation, only Stanley Bradley purchased the bid documents and submitted its bid in a public bidding held on 13 August 2019, 3:00 p.m. at Room 315, 3rd Floor, Delas Alas Hall Building, DOJ Compound, Padre Faura Street, Ermita, Manila, to wit,

WHEREAS, the aforesaid bid was referred to the DOJ Bids and Awards Committee-Technical Working Group (BAC-TWG) for evaluation and post-qualification with the following findings:

WHEREAS, after review and evaluation of the DOJ BAC-TWG finds that Stanley Bradley is legally, financially, and technically capable to undertake the subject procurement. Hence, for having submitted a Single Calculated and Responsive Bid (SCRB), it recommended the award of Contract in favor of Stanley Bradley in its evaluated bid of One Million Seven Hundred Eighty Five Thousand Three Hundred Seventy Six Pesos (P1,785,376.00);

NOW, THEREFORE, after thorough deliberation, the Bids and Award Committee resolves, as it hereby resolve, to **RECOMMEND** the award of contract to Stanley Bradley Trading, Inc. for the purchase of consumables for various printers not available in the Procurement Service in the total amount of **ONE MILLION SEVEN HUNDRED EIGHTY FIVE THOUSAND THREE HUNDRED SEVENTY SIX PESOS (P1,785,376.00)**.




