RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT TO STANLEY BRADLEY TRADING INC. FOR THE PURCHASE OF HARD KRAFT BOXES

WHEREAS, there is a need for the purchase of hard kraft boxes;

WHEREAS, the purchase of the aforementioned goods is included in the CY2019 Supplemental Annual Procurement Plan No. 5 (SAPP No. 5);

WHEREAS, the Approved Budget for the Contract under Small Value Procurement is P390,000.00

WHEREAS, the DOJ posted its Invitation to Bid/Request for Quotation for the purchase of the subject items in the PhilGEPS, DOJ Website, and conspicuous place in the Department continuously for five (5) calendar days and was sent to three (3) prospective suppliers, namely: Tanteko Stationary, Stanley Bradley Trading Inc., and Seebings Industrial Sales Co. Inc.;

WHEREAS, in response to the said invitation, only one (1) prospective supplier submitted its quotation, to wit,

WHEREAS, after review and evaluation, the DOJ BAC-TWG found that Stanley Bradley Trading Inc. is legally, financially, and technically capable to undertake the subject procurement, and for having submitted a Single Calculated and Responsive Quotation (SCRQ);

WHEREAS, considering that the amount involved in the subject procurement is **THREE HUNDRED EIGHTY THOUSAND PESOS (P380,000.00)**, an alternative mode of procurement is allowed by GPRA, provided, that the amount shall not exceed the thresholds prescribed in Annex "H" of the 2016 Revised Implementing Rules and Regulations;

NOW, THEREFORE, for and in consideration of the foregoing, the Bids and Awards Committee **RESOLVES**, as it hereby resolve, to **RECOMMEND** the approval of Small Value Procurement as an alternative mode of

procurement, and the award of contract to **Stanley Bradley Trading Inc.** for the purchase of hard kraft boxes in the amount of **THREE HUNDRED EIGHTY THOUSAND PESOS (P380,000.00)**.


