RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT TO LUCKY MAGIC LIGHT TRADING CO. FOR THE PURCHASE OF LED CURTAIN LIGHTS, LED CHRISTMAS LIGHTS AND LED AUTOMATIC EMERGENCY LIGHTS

WHEREAS, there is a need to purchase LED Curtain Lights, LED Christmas Lights and LED Automatic Emergency Lights;

WHEREAS, the purchase of the aforementioned goods is included in the CY2019 Supplemental Annual Procurement Plan No. 5 (SAPP No. 5);

WHEREAS, the Approved Budget for the Contract under small value procurement is P349,100.00

WHEREAS, the DOJ posted its Invitation to Bid/Request for Quotation for the purchase of the subject items in the PhilGEPS, DOJ Website, and conspicuous place in the Department continuously for four (4) calendar days and was sent to three (3) prospective suppliers, namely: Santa Manila, Ecoshift Corporation and Arrow Electrical;

WHEREAS, in response to the said invitation, three (3) prospective suppliers submitted their quotation, to wit,

WHEREAS, after review and evaluation, the DOJ BAC-TWG found that Lucky Magic Light Trading Co. is legally, financially, and technically capable to undertake the subject procurement, and for having submitted the Single Calculated and Responsive Quotation (SCRQ);

WHEREAS, considering that the amount involved in the subject procurement is **TWO HUNDRED FORTY NINE THOUSAND THREE HUNDRED PESOS (P249,300.00)**, an alternative mode of procurement is allowed by GPRA, provided, that the amount shall not exceed the thresholds prescribed in Annex "H" of the 2016 Revised Implementing Rules and Regulations;

NOW, THEREFORE, for and in consideration of the foregoing, the Bids and Awards Committee **RESOLVES**, as it hereby resolve, to **RECOMMEND** the approval of Small Value Procurement as an alternative mode of procurement, and the award of contract to **Lucky Magic Light Trading Co.** for the purchase of LED Curtain Lights, LED Christmas Lights and LED Automatic Emergency Lights in the amount of **TWO HUNDRED FORTY NINE THOUSAND THREE HUNDRED PESOS (P249,300.00)**.


