## RESOLUTION

### RECOMMENDING THE AWARD OF CONTRACT TO ZASHEN FASHIONS FOR THE PURCHASE OF OADR ADVOCACY T-SHIRTS

**WHEREAS**, there is a need to purchase OADR Advocacy T-Shirts;

**WHEREAS**, the purchase of the aforementioned goods is included in the Approved Annual Procurement Plan (APP) for CY 2019;

**WHEREAS**, the Approved Budget for the Contract under small value procurement is P229,390.00

**WHEREAS**, the DOJ posted its Invitation to Bid/Request for Quotation for the purchase of the subject items in the PhilGEPS, DOJ Website, and conspicuous place in the Department continuously for five (5) calendar days, and was sent to four (4) prospective suppliers, namely: Jaz Printing & Services, Transfer It, Mariqueno Ink Shirt Clothing, and Kamatee's Designs and Printing Services;

**WHEREAS**, in response to the said invitation, three (3) prospective suppliers submitted their quotations, to wit,

**WHEREAS**, after review and evaluation, the DOJ BAC-TWG found that Zashen Fashions is legally, financially, and technically capable to undertake the subject procurement, and for having submitted the Lowest Calculated and Responsive Quotation (LCRQ);

**WHEREAS**, considering that the amount involved in the subject procurement is **ONE HUNDRED FIFTY ONE THOUSAND PESOS (P151,000.00)**, an alternative mode of procurement is allowed by GPRA, provided, that the amount shall not exceed the thresholds prescribed in Annex "H" of the 2016 Revised Implementing Rules and Regulations;

**NOW, THEREFORE**, for and in consideration of the foregoing, the Bids and Award Committee RESOLVES, as it hereby resolve, to **RECOMMEND** the approval of Small Value Procurement as an alternative mode of procurement, and the award of contract to **Zashen Fashions** for the purchase of OADR Advocacy T-Shirts in the amount of **ONE HUNDRED FIFTY ONE THOUSAND PESOS (P151,000.00)**.
