RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT TO 1938 FRANCISCO FOOD SPECIALTIES, INC. FOR THE PURCHASE OF SNACKS IN CONNECTION WITH THE CEREMONIAL LIGHTING AT THE DEPARTMENT OF JUSTICE (DOJ) ON 29 NOVEMBER 2019

WHEREAS, there is a need for the purchase of snacks in connection with the Ceremonial Lighting at the Department of Justice (DOJ) on 29 November 2019;

WHEREAS, the purchase of the aforementioned goods is included in the CY2019 Annual Procurement Plan;

WHEREAS, the Approved Budget for the Contract under small value procurement is P75,000.00

WHEREAS, the DOJ posted its Invitation to Bid/Request for Quotation for the purchase of the subject items in the PhilGEPS, DOJ Website, and conspicuous place in the Department continuously for four (4) calendar days and was sent to six (6) prospective suppliers, namely: 1938 Francisco Food Specialties, Inc., Via Mare Catering, 8 Spoons Catering, CMDL Catering Services, Jems Catering Services, and Hizon's Catering Services, Inc.;

WHEREAS, in response to the said invitation, three (3) prospective suppliers submitted their quotation, to wit,

WHEREAS, after review and evaluation, the DOJ BAC-TWG found that 1938 Francisco Food Specialties, Inc. is legally, financially, and technically capable to undertake the subject procurement, and for having submitted the Single Calculated and Responsive Quotation (SCRQ);

WHEREAS, considering that the amount involved in the subject procurement is **SEVENTY FIVE THOUSAND PESOS (P75,000.00)**, an alternative mode of procurement is allowed by GPRA, provided, that the amount shall not exceed the thresholds prescribed in Annex "H" of the 2016 Revised Implementing Rules and Regulations;

NOW, THEREFORE, for and in consideration of the foregoing, the Bids and Awards Committee **RESOLVES**, as it hereby resolve, to **RECOMMEND** the approval of Small Value Procurement as an alternative mode of procurement, and the award of contract to **1938 Francisco Food Specialties, Inc.** for the purchase of snacks in connection with the Ceremonial Lighting at the DOJ on 29 November 2019 in the amount of **SEVENTY FIVE THOUSAND PESOS (P75,000.00)**.


