RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT TO REX BOOK STORE, INC. FOR THE PURCHASE OF VARIOUS BOOKS FOR THE OFFICE FOR ALTERNATIVE DISPUTE RESOLUTION LIBRARY

WHEREAS, there is an urgent need for the purchase of various books for the Office for Alternative Dispute Resolution (OADR) Library;

WHEREAS, the procurement of the said books is included in the CY 2019 Supplemental Annual Procurement Plan No. 6 (SAPP 6) with an allotted budget of Five Hundred Thousand Pesos (P500,000.00);

WHEREAS, in a certification dated 19 November 2019, Mr. Franklin Benedict T. Guerra, National Manager of Rex Bookstore Inc., stated that Rex Book Store, Inc. is the only publisher and exclusive distributor of the following books, to wit:

WHEREAS, in the price quotation dated 11 November 2019 submitted by Mr. Arvi Sandoval of Rex Book Store, Inc., the total cost for the purchase of said books is Thirteen Thousand Four Hundred Ninety-One Pesos & 60/100 (P13,491.60);

WHEREAS, direct contracting¹ may be resorted to when the procurement of goods of proprietary nature which can be obtained only from the proprietary source, *i.e.* when patents, trades secrets, and copyrights prohibit others from manufacturing the same item;
