## **-RESOLUTION**

### **RECOMMENDING THE AWARD OF CONTRACT TO SEE MANUFACTURING CONTRACTOR FOR THE PURCHASE OF VARIOUS FURNITURE AND FIXTURES**

**WHEREAS**, there is a need for the purchase of various furniture and fixtures;

**WHEREAS**, the Department of Justice (DOJ) posted its Invitation to Bid for the aforesaid procurement in the PhilGEPS, DOJ Website, and conspicuous place in the DOJ for more than seven (7) calendar days starting 31 July 2019;

**WHEREAS**, the purchase of the aforementioned project is included in the CY-2019 Supplemental Annual Procurement Plan No. 1(SAPP-No.1);

**WHEREAS**, the Approved Budget for the Contract is One Million Five Hundred Thirty-Four Thousand Sixty-Six Pesos and 70/100 (P1,534,066.70);

**WHEREAS**, in response to the said invitation, five (5) prospective suppliers submitted its bid in a public bidding held on 27 August 2019, 2:00 p.m. at Room 315, 3<sup>rd</sup> Floor, Delas Alas Hall Building, DOJ Compound, Padre Faura Street, Ermita, Manila, to wit:

**WHEREAS**, the aforesaid bids were referred to the DOJ Bids and Awards Committee-Technical Working Group (BAC-TWG) for evaluation and post-qualification, with the following findings:




