**BAC RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID AND RECOMMENDING APPROVAL FOR THE SUPPLY AND DELIVERY OF VARIOUS SEMI-EXPENDABLE FURNITURE AND FIXTURES**
