RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT TO SUPER-AIRE REFRIGERATION AND CONTRACTORS, INC. FOR THE REPLACEMENT OF OUTDOOR PCB BOARD OF ONE (1) UNIT KOPPEL 1.5 HP INVERTER WALL MOUNTED TYPE AIRCONDITIONER WITH SERIAL NO. LJ584249, INSTALLED AT THE OFFICE OF SSP PHILLIP DELA CRUZ, ROOM 303, 3RD FLOOR, DELAS ALAS HALL, DEPARTMENT OF JUSTICE

WHEREAS, there is a need for the replacement of outdoor PCB Board of one (1) unit Koppel 1.5 HP inverter wall mounted type airconditioner with serial no. LJ584249, installed at the office of SSP Dela Cruz, Room 303, 3rd floor, Delas Alas Hall;

WHEREAS, the replacement of the said PCB Board is included in the approved FY 2019 Annual Procurement Plan (APP), with an allotted budget of **Four Hundred Twenty Thousand Pesos (P420,000.00)**;

WHEREAS, pursuant to the *Procedures for Small Value Procurement*¹, the Department requested from three (3) companies to submit quotations, namely: Super-Aire Refrigeration and Contractors, Inc., Clarkson Industrial Supply, Inc., and Sundria Airconditioning Services;

WHEREAS, among the three companies that submitted its quotation, **Super-Aire Refrigeration and Contractors, Inc.** provided the lowest calculated quotation/bid, as follows:


