**BAC RESOLUTION RECOMMENDING THE AWARD OF CONTRACT TO  
NEWTOWN PLAZA HOTEL FOR THE CONDUCT OF TRAINING ON  
GENDER AND DEVELOPMENT ON DECEMBER 12, 2019**

**WHEREAS**, there is a need for a supplier to provide accommodation for the conduct of the training on Gender and Development for prosecutors and support staff of the Department of Justice-National Prosecution Service, Region 1 on December 12, 2019 in Baguio City;

**WHEREAS**, the procurement of accommodation has an Approved Budget for the Contract of Three Hundred Forty-One Thousand Pesos (P341, 000.00);

**WHEREAS**, the Regional Prosecution Office 1, through the Bids and Awards Committee, posted the Request for Quotation for the subject procurement in the PhilGEPS, and conspicuous place in the premises of City of San Fernando, La Union and the Justice Hall Sevilla, San Fernando City, La Union continuously from November 21-25, 2019. The BAC also requested from three (3) suppliers to submit quotations namely: a.) Newtown Plaza Hotel, b.) Microtel by Wyndham- Baguio, and c.) The Forest Lodge at Camp John Hay;

**WHEREAS**, in response to the invitation, only Newtown Plaza Hotel and Microtel By Wyndham- Baguio replied. Their proposals are as follows;

**WHEREAS**, after due evaluation and assessment of the quotations received, the BAC declared Microtel By Wyndham-Baguio non-responsive and found the offer of Newtown Plaza Hotel as the lowest calculated and responsive bid;

**NOW, THEREFORE**, We, the members of the Bids and Awards Committee, hereby resolve as it is hereby **RESOLVED** to recommend that:

Award of Contract be given to Newtown Plaza Hotel as the service provider with the lowest calculated and responsive bid for the accommodation of the participants for the above-mentioned training in the amount of **Three Hundred Forty Thousand Nine Hundred Pesos (P340, 900.00)**.
