## RESOLUTION

### **A RESOLUTION RECOMMENDING THE AWARD OF CONTRACT TO MB CATERING SERVICES FOR SNACKS ON THE CONDUCT OF SCHOOL CARAVAN 2019, CAPIZ NATIONAL HIGH SCHOOL, ROXAS CITY, CAPIZ**

**WHEREAS**, there is a need for a snacks for the conduct of School Caravan 2019 to be held on 8<sup>th</sup> of November, Roxas City, Capiz;

**WHEREAS**, among the three (3) suppliers that submitted its quotations, and based from the rating factors submitted by the end-user, **Vincent Catering Services** provided the lowest calculated and responsive quotation;

**NOW, THEREFORE**, for and in consideration of the foregoing premises, the Department of Justice, Bids and Awards Committee **RESOLVES**, as it hereby resolve, to **RECOMMEND** the award of contract to **Vincent Catering Services**, for the conduct of School Caravan 2019 to be held on 8 November 2019 in Capiz National School, Roxas City, Capiz in the amount of **Fifty Thousand Pesos ( P 50,000.00)** following the procedures prescribed by R.A. No. 9184 and its 2016 Revised Implementing Rules and Regulations.


