RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT TO CONTACTPOINT, INC. FOR THE SUBSCRIPTION OF SOFTWARE FOR UNIVERSAL FORENSIC EXTRACTION DEVICE LICENSE

WHEREAS, there is a need for the subscription of Universal Forensic Extraction Device (UFED) License for the use of the Office of Cybercrime (OOC) of the Department of Justice (DOJ);

WHEREAS, the DOJ posted its Invitation to Bid for the aforesaid subscription in the PhilGEPS, DOJ Website, and conspicuous place in the DOJ for more than seven (7) calendar days starting 29 August 2019;

WHEREAS, the subscription of the said license is included in the FY 2019 Annual Procurement Plan (APP) with an allotted budget of Eight Hundred Thousand Pesos (P800,000.00);

WHEREAS, the Approved Budget for the Contract is Seven Hundred Thousand Pesos (P700,000.00);

WHEREAS, in response to the said invitation, one (1) prospective supplier submitted its bid in a public bidding held on 11 October 2019, 2:00 pm at Room 105, Ground Floor, Delas Alas Building, DOJ Compound, Padre Faura Street, Ermita, Manila, to wit,
