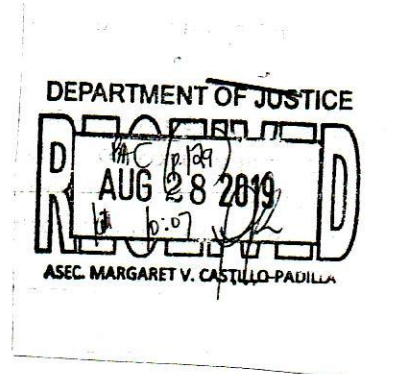

## RESOLUTION

### RECOMMENDING THE AWARD OF CONTRACT TO MAXCOR INTER-VENTURES CO. FOR THE SUBSCRIPTION OF A UNIVERSAL FORENSIC EXTRACTION DEVICE FOR THE USE OF OFFICE OF CYBERCRIME

**WHEREAS**, there is an urgent need for the subscription of a universal forensic extraction device for the use of the Office of Cybercrime;

**WHEREAS**, the Department of Justice (DOJ) posted its Invitation to Bid for the aforesaid procurement in the PhilGEPS, DOJ Website, and conspicuous place in the DOJ for more than seven (7) calendar days starting 18 June 2019;

**WHEREAS**, the purchase of the aforementioned project is included in the approved Annual Procurement Plan (APP) for CY 2019;

**WHEREAS**, the Approved Budget for the Contract is Eight Hundred Thousand Pesos (P800,000.00);

**WHEREAS**, in response to the said invitation, only Maxcor Inter-Ventures Co. submitted its bid in a public bidding held on 9 July 2019, 3:00 p.m. at Room 315, 3<sup>rd</sup> Floor, Delas Alas Hall Building, DOJ Compound, Padre Faura Street, Ermita, Manila, to wit,


