RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT TO PRONET SYSTEM INTEGRATED NETWORK SOLUTIONS, INC. FOR THE SUPPLY AND DELIVERY OF 16 UNITS OF FIREWALL

WHEREAS, there is a need for the supply and delivery of 16 units of firewall;

WHEREAS, the DOJ posted its Invitation to Bid for the aforesaid purchase in the PhilGEPS, DOJ Website, and conspicuous place in the DOJ for more than seven (7) calendar days starting 5 August 2020;

WHEREAS, the purchase of the said items is included in the CY 2020 Supplemental Annual Procurement Plan No. 4 (SAPP 4) with an allotted budget of Five Million Two Hundred Forty-Eight Thousand Pesos (P5,248,000.00);

WHEREAS, the Approved Budget for the Contract is Five Million Two Hundred Forty-Eight Thousand Pesos (P5,248,000.00);

WHEREAS, in response to the said invitation, two (2) prospective suppliers submitted their bids in a public bidding (*via google*) held on 25 August 2020, 2:00 p.m., to wit,
