**RESOLUTION No. 5 s. 2019**

**RECOMMENDING THE AWARD OF CONTRACT TO REGINA'S GARDEN AND RESTAURANT AND THE APPROVAL OF PURCHASE ORDER NO. 2019-05-004 FOR THE PROCUREMENT OF CATERING SERVICES FOR THE SEMINAR ON STRESS MANAGEMENT ON JUNE 20, 2019 AT TRAINING CENTER, LINGAYEN, PANGASINAN**

**WHEREAS**, the Regional Prosecution Office 1, through the Bids and Awards Committee, posted the Invitation to Bid for the procurement of catering services for the above-mentioned seminar with an Approved Budget for the Contract of Two Hundred Ninety-Seven Thousand Five Hundred Pesos (P297, 500.00) in the PhilGEPS, and conspicuous place in the premises of City of San Fernando, La Union and the Justice Hall Sevilla, San Fernando City, La Union continuously from April 22-26, 2019;

**WHEREAS**, in response to the advertisement, three (3) prospective caterers signified their intent to participate in the bidding, to wit:

**WHEREAS**, as a result of bid opening, Regina's Garden and Restaurant was declared the Lowest Calculated Bidder (LCB);

**WHEREAS**, upon careful examination, validation and verification of all the eligibility, technical and financial documents submitted by the LCB, the BAC found the offer of Regina's Garden and Restaurant to be compliant and responsive;

**NOW, THEREFORE**, We, the members of the Bids and Awards Committee, hereby resolve as it is hereby **RESOLVED** to recommend the following:

- a. to declare Regina's Garden and Restaurant as the bidder with the Lowest Calculated and Responsive Bid, and;
- b. to recommend the award and approval of the Purchase Order No. 2019-05-004 in the amount of **Two Hundred Fifty Five Thousand Five Hundred Pesos (P255, 500.00)** for the supply of catering services for the Seminar on Stress Management on June 20, 2019 in favor of Regina's Garden and Restaurant .
