

INVITATION TO BID

The Department of Justice (DOJ), through the Bids and Awards Committee (BAC) is inviting interested parties to bid for the following projects:

1. Purchase of Various Furniture, Cabinets and Partition for DOJ
 - Approved Budget for the Contract – P 5,444,400.00
 - Delivery Period - 45 calendar days
2. Purchase of Ink Bottles for EPSON L-485 Printers
 - Approved Budget for the Contract – P 1,062,600.00
 - Delivery Period - 30 calendar days
3. Printing of OADR Information and Educational Campaign Materials
 - Approved Budget for the Contract – P 750,000.00
 - Delivery Period – 30 calendar days
4. Purchase of two (2) units Precision Airconditioning Unit (PACU) for NJIS Data Center and MISD Server Room
 - Approved Budget for the Contract – P 1,500,000.00
 - Delivery Period – 45 calendar days
5. Purchase of Core Switch (for network redundancy)

The prospective bidders must have an experience of having completed, within a period of ten (10) years from date of submission and receipt of bids, at least one (1) contract similar to the contract to be bid, and whose value, adjusted to current price using NSO consumer price indices, must be at least fifty percent (50%) of the ABC to be bid. The Eligibility Check/ Screening as well as the Preliminary Examination of Bids shall use non-discretionary “pass/fail” criteria. Post-qualification of the lowest calculated bid shall be conducted.

All particulars relative to Eligibility Statement and Screening, Bid Security, Performance Security, Pre-bidding Conference, Evaluation of Bids, Post-Qualification and Award of contract shall be governed by the pertinent provisions of the Revised Implementing Rules and Regulation (IRR) of Republic Act No. 9184 dated 28 October 2016.

All prospective bidders shall be charged a non-refundable bid fee in the amount of **P10,000.00 each for Item Nos. 1, 5 & 6, P5,000.00 each for Item Nos. 2, 4 & 7 and P1,000.00 for Item No. 3.**

The Department of Justice reserves its right to reject any or all bids, should there be any defect therein, accepts the offer most advantageous to the government, and assumes no responsibility whatsoever to compensate or indemnify bidders for any expense incurred in the preparation of the bid.
