**RESOLUTION**

**RECOMMENDING THE AWARD OF CONTRACT TO  
REMAX INTERNATIONAL, INC. FOR THE PURCHASE OF  
ONE THOUSAND EIGHT HUNDRED (1800) UNITS LAPTOP COMPUTERS**

**WHEREAS**, the Department of Justice (DOJ) posted its Invitation to Bid for the purchase of one thousand eight hundred (1800) units laptop computers in the PhilGEPS, DOJ Website, bulletin boards of Manila City Hall, and Department of Justice, continuously for a minimum of seven (7) days, and published in the Philippine Daily Inquirer for two (2) consecutive days;

**WHEREAS**, in response to the said invitation, three (3) prospective bidders, namely: Remax International, Inc. (Remax), Masangkay Computer Center (Masangkay), and Advance Solutions Inc. (Advance) purchased the bid documents;

**WHEREAS**, in a public bidding held on 27 December 2017 at 2:00 p.m. at the Conference Room, Room 313, 3rd floor De Las Alas Hall (formerly DOJ Main Bldg.), Remax, Masangkay and Advance passed the preliminary evaluation of the bid requirements ;

**WHEREAS**, after the conduct of the bidding, the bid documents were referred to the Technical Working Group (TWG)/Secretariat of the BAC for post-qualification evaluation of the bid;

**WHEREAS**, the Approved Budget for the Contract (ABC) under bidding is P100,000,000.00;

**WHEREAS**, the result of the post-qualification evaluation conducted by the TWG is as follows:

**WHEREAS**, the BAC, after further evaluation, finds the recommendation of the BAC-TWG/Secretariat to award the contract in favor of Remax in the total amount of P92,444,094.00 to be reasonable and most advantageous to the government;

**NOW, THEREFORE**, the Bids and Awards Committee, after thorough deliberation, **RESOLVES** as it hereby **RESOLVES** to recommend, the **GRANT** of the award of contract to Remax International, Inc. for the purchase of one thousand eight hundred (1800) units laptop computers, in the total amount **NINETY TWO MILLION FOUR HUNDRED FORTY FOUR THOUSAND NINETY FOUR PESOS (P92,444,094.00)**.


