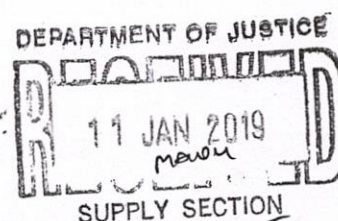

RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT TO LINK NETWORK SOLUTIONS INC. FOR THE PURCHASE OF VARIOUS INK CARTRIDGES AND TONERS FOR VARIOUS PRINTERS OF DOJ OFFICES

WHEREAS, the Department of Justice (DOJ) posted its Invitation to Bid for the purchase of various ink cartridges and toners for various printers of DOJ offices in the PhilGEPS, DOJ Website, bulletin boards of Manila City Hall, and DOJ, continuously for a minimum of seven (7) days;

WHEREAS, in response to the said invitation, two (2) prospective bidders purchased the bid documents namely: Integrated Computers Systems (Integrated); and Link Network Solutions, Inc. (Link);

WHEREAS, in a public bidding held on 27 December 2018, 11:00 a.m. at Room 315, 3rd floor, De Las Alas Hall (formerly DOJ Main Bldg.), DOJ Compound, Padre Faura Street, Ermita, Manila, both Integrated and Link passed the preliminary evaluation of the bid requirements;

WHEREAS, after the conduct of the bidding, the bid documents were referred to the Technical Working Group (TWG)/Secretariat of the BAC for post-qualification and evaluation of the bids;

WHEREAS, the Approved Budget for the Contract (ABC) under bidding is ₱2,771,830.66;

WHEREAS, the result of the evaluation by the TWG is as follows:

WHEREAS, the calculated bid of Link in the amount of ₱2,567,003.00 is 7.39% below the ABC, and was found to have post-qualified with all the legal, technical and financial requirements. Therefore, Link is considered to be the winning bidder with the Lowest Calculated and Responsive Bid;

WHEREAS, the BAC-TWG/Secretariat has recommended the award of the contract in favor of Link in its calculated bid of ₱2,567,003.00;

WHEREAS, the BAC, after further evaluation, finds the recommendation of the BAC TWG/Secretariat to award the contract in favor of Link in the total amount of ₱2,567,000.00 to be reasonable and most advantageous to the government;

NOW, THEREFORE, the Bids and Awards Committee, after a thorough deliberation, resolves, as it hereby **RESOLVE** to recommend the award of contract to Link Network Solutions, Inc. for the purchase of various ink cartridges and toners for various printers for DOJ offices, in the total amount of **TWO MILLION FIVE HUNDRED SIXTY SEVEN THOUSAND AND THREE PESOS (₱2,567,003.00)**.
