**RESOLUTION**

**RECOMMENDING THE AWARD OF CONTRACT TO WISMON CONSTRUCTION & DEVELOPMENT CORP. FOR THE DESIGN AND BUILD OF TWO-STOREY BUILDING AT QUEZON CITY**

**WHEREAS**, the Department of Justice (DOJ) published its Invitation to Bid for the Design and Build of a Two-Storey Building at Quezon City in the Philippine Daily Inquirer for one (1) day (November 22, 2018) and was posted in the PhilGEPS, DOJ Website, bulletin board of Manila City Hall and DOJ continuously for a minimum of seven (7) days;

**WHEREAS**, in response to the said invitation, one (1) prospective bidder purchased the bid documents, namely; Wismon Construction & Development Corp.;

**WHEREAS**, in a public bidding held on December 17, 2018 at 10:00 a.m. at room 315, 3<sup>rd</sup> Floor, De Las Alas Hall, Wismon Construction & Development Corp. submitted its bid and passed the preliminary evaluation of the bid requirements;

**WHEREAS**, Section 36 of the 2016 Implementing Rules and Regulations of Republic Act No. 9184 provides: "A single calculated/rated and responsive bid shall be considered for award if it falls under any of the following circumstances: xxx a) If after advertisement, only one prospective bidder submits an LOI and/or applies for eligibility check, in accordance with the provisions of this IRR, and it meets the eligibility requirements or criteria, after which it submits a bid which is found to be responsive to the bidding requirements";

**WHEREAS**, after the bidding, the bid documents were referred to the Technical Working Group (TWG) of the Bids and Awards Committee for evaluation of the bid and post-qualification;

**WHEREAS**, the Approved Budget for the Contract (ABC) under bidding is P14,238,720.00;

**WHEREAS**, the result of the evaluation by the TWG is as follows:






