**RESOLUTION**

**RECOMMENDING THE AWARD OF CONTRACT TO VIGILANT INVESTIGATIVE AND SECURITY AGENCY, INC. FOR THE SECURITY SERVICES WITHIN THE DEPARTMENT PROPER INCLUDING BOARD OF PARDONS & PAROLE IN QUEZON CITY AND OFFICES OF THE CITY PROSECUTORS IN MALABON, NAVOTAS AND QUEZON CITY, SUNNY OAK, INC. BLDG. AND GIRLS SCOUT BLDG.**

**WHEREAS**, the Department of Justice (DOJ) published its Invitation to Bid for the Security Services within the Department Proper, including Board of Pardons & Parole in Quezon City and Offices of the City Prosecutors in Malabon, Navotas and Quezon City, Sunny Oak, Inc. Bldg. and Girls Scout Bldg. in the Philippine Daily Inquirer for one (1) day (21 November 2018), PhilGEPS, DOJ Website, bulletin boards of Manila City Hall, and DOJ, continuously for a minimum of seven (7) days;

**WHEREAS**, in response to the said invitation, only (1) prospective bidder purchased the bid documents i.e., Vigilant Investigative and Security Agency, Inc. (Vigilant);

**WHEREAS**, in a public bidding held on 13 December 2018, 10:00 a.m. at Room 315, 3<sup>rd</sup> floor, De Las Alas Hall (formerly DOJ Main Bldg.), DOJ Compound, Padre Faura Street, Ermita, Manila, Vigilant passed the preliminary evaluation of the bid;

**WHEREAS**, Section 36 of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 provides: "A Single Calculated and Responsive Bid (SCRB) shall be considered for award if it falls under any of the followings circumstances: xxx a) If after advertisement, only one prospective bidder applies for eligibility check, in accordance with the provisions of this IRR, and it meets the eligibility requirements or criteria, after which it submits a bid which found to be responsive to the bidding requirements";

**WHEREAS**, after the conduct of the bidding, the bid documents were referred to the Technical Working Group (TWG)/Secretariat of the BAC for post-qualification evaluation of the bid;

**WHEREAS**, the Approved Budget for the Contract (ABC) under bidding is ₱9,681,941.88;



**WHEREAS**, the result of the evaluation by the TWG is as follows:

**WHEREAS**, the calculated bid of Vigilant in the amount of ₱8,314,031.88 is 14.13% below the ABC, and was found to have post-qualified with all the legal, technical and financial requirements. Therefore, Vigilant is considered to be the winning bidder with the Lowest Calculated and Responsive Bid;


**WHEREAS**, the BAC-TWG/Secretariat has recommended the award of the contract in favor of Vigilant in its calculated bid of ₱8,314,031.88;

**WHEREAS**, the BAC, after further evaluation, finds the recommendation of the BAC TWG/Secretariat to award the contract in favor of Vigilant in the total amount of ₱8,314,031.88 to be reasonable and most advantageous to the government;

**NOW, THEREFORE**, the Bids and Awards Committee, after a thorough deliberation, resolves, as it hereby **RESOLVE** to recommend the award of contract to Vigilant Investigative and Security Agency, Inc. for the Security Services within Department Proper including Board of Pardons & Parole in Quezon City and Offices of the City Prosecutors in Malabon, Navotas and Quezon City, Sunny Oak, Inc. Bldg. and Girls Scout Bldg., in the total amount of **EIGHT MILLION THREE HUNDRED FOURTEEN THOUSAND THIRTY ONE PESOS AND EIGHTY EIGHT CENTAVOS (₱8,314,031.88)**.


