RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT TO AREZA MOTOR SALES FOR THE PURCHASE OF THREE (3) UNITS PASSENGER VAN FOR INTER-AGENCY COUNCIL AGAINST TRAFFICKING (IACAT)

WHEREAS, the Department of Justice (DOJ) published its Invitation to Bid for the purchase of three (3) units passenger van for Inter-Agency Council Against Trafficking (IACAT) in the Philippine Daily Inquirer for one (1) day (26 November 2018), PhilGEPS, DOJ Website, bulletin boards of Manila City Hall, and DOJ, continuously for a minimum of seven (7) days;

WHEREAS, in response to the said invitation, only one (1) prospective bidder purchased the bid documents namely: Areza Motor Sales (Areza);

WHEREAS, in a public bidding held on 17 December 2018 at 1:30 p.m. at Room 315, 3rd floor, De Las Alas Hall (formerly DOJ Main Bldg.), DOJ Compound, Padre Faura Street, Ermita, Manila, Areza passed the preliminary evaluation of the bid requirements;

WHEREAS, Section 36 of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 provides: "A Single Calculated and Responsive Bid (SCRB) shall be considered for award if it falls under any of the followings circumstances: xxx a) If after advertisement, only one prospective bidder applies for eligibility check, in accordance with the provisions of this IRR, and it meets the eligibility requirements or criteria, after which it submits a bid which found to be responsive to the bidding requirements";

WHEREAS, after the conduct of the bidding, the bid documents were referred to the Technical Working Group (TWG)/Secretariat of the BAC for post-qualification and evaluation of the bids;

WHEREAS, the Approved Budget for the Contract (ABC) under bidding is ₱4,331,502.75;

WHEREAS, the result of the evaluation by the TWG is as follows:

1 BAC Resolution

Purchase of 3 units Passenger Van for IACAT

WHEREAS, the findings during bid/post-qualification evaluation report of the BAC-Technical Working Group (BAC-TWG), there is a discrepancy between the bid price as read in figures P4,331,000.00 and in words P4,329,000.00, under Section 32.2.3 of the 2016 Revised IRR provides: In Case of discrepancy: xxx a) Bid prices in figures and in words, the latter shall prevail.”;


WHEREAS, the calculated bid of Areza in the amount of P4,329,000.00 is 0.06% below the ABC, and was found to have post-qualified with all the legal, technical and financial requirements. Therefore, Areza is considered to be the winning bidder with the Single Calculated and Responsive Bid;

WHEREAS, the BAC-TWG/Secretariat has recommended the award of the contract in favor of Areza in its calculated bid of P4,329,000.00;

WHEREAS, the BAC, after further evaluation, finds the recommendation of the BAC TWG/Secretariat to award the contract in favor of Areza in the total amount of P4,329,000.00 to be reasonable and most advantageous to the government;

NOW, THEREFORE, the Bids and Awards Committee, after a thorough deliberation, resolves, as it hereby **RESOLVE** to recommend the award of contract to Areza Motor Sales for the purchase of three (3) units passenger van for Inter-Agency Council Against Trafficking (IACAT), in the total amount of **FOUR MILLION THREE HUNDRED TWENTY NINE THOUSAND PESOS (P4,329,000.00)**.


