RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT TO ADROW CREATIVES, INC. FOR THE PRODUCTION OF OFFICE FOR ALTERNATIVE DISPUTE RESOLUTION (OADR) INSTITUTION VIDEO

WHEREAS, the Department of Justice (DOJ) posted its Invitation to Bid for the production of Office for Alternative Dispute Resolution (OADR) institution video in the PhilGEPS, DOJ Website, bulletin boards of Manila City Hall, and Department of Justice, continuously for a minimum of seven (7) days;

WHEREAS, in response to the said invitation, two (2) prospective bidders purchased the bid documents, namely: Creative Point International, Inc. (Creative Point); and Adrow Creative Inc. (Adrow);

WHEREAS, in a public bidding held on 05 December 2017 at 10:00 a.m. at Room 313 conference room of the Bids and Awards Committee (BAC) Chairperson, 3rd floor, De Las Alas Hall (formerly DOJ Main Bldg.), only Adrow Creatives, Inc. passed the preliminary evaluation of the bid requirements, while Creative Point International Inc. failed to submit its bid or a letter of withdrawal;

WHEREAS, after the conduct of the bidding, the bid documents were referred to the Technical Working Group (TWG)/Secretariat of the Bids and Awards Committee (BAC) for post-qualification and evaluation of the bid;

WHEREAS, the Approved Budget for the Contract (ABC) under bidding is ₱950,000.00;

WHEREAS, the result of the evaluation by the TWG is as follows:

WHEREAS, the calculated bid of Adrow in the amount of ₱578,777.00 is 39.08% below the ABC, and was found to have post-qualified with all the legal, technical and financial requirements. Therefore, Adrow is considered to be the winning bidder with the Lowest Calculated and Responsive Bid;

WHEREAS, the BAC TWG/Secretariat has recommended the award of the contract in favor of Adrow in its calculated bid of ₱578,777.00;

WHEREAS, the BAC, after further evaluation, finds the recommendation of the BAC TWG/Secretariat to award the contract in favor of Adrow in the total amount of ₱578,777.00 to be reasonable and most advantageous to the government;

NOW, THEREFORE, the Bids and Awards Committee (BAC), after thorough deliberation, **RESOLVES**, as it hereby **RESOLVE** to recommend the **GRANT** of the award of contract to Adrow Creatives, Inc. for the production of Office for Alternative Dispute Resolution (OADR) institution video, in the total amount of **FIVE HUNDRED SEVENTY EIGHT THOUSAND SEVEN HUNDRED SEVENTY SEVEN PESOS (₱578,777.00)**.
