The Department of Justice (DOJ), through the Bids and Awards Committee (BAC) is inviting interested parties to bid for the following Projects:

**1) Procurement of Renewal of Firewall and Management Appliance License for DOJ Main**

Approved Budget of the Contract : P 5,500,000.00  
Delivery Period : 45 calendar days  
Location : DOJ Padre Faura St., Ermita, Manila

**2) Procurement of Renewal of Firewall License for NPS NCR Offices**

Approved Budget of the Contract : P 4,500,000.00  
Delivery Period : 45 calendar days  
Location : DOJ Padre Faura St., Ermita, Manila

**3) Procurement of Next-Generation Firewall for DOJ Disaster Recovery Site**

Approved Budget of the Contract : P 3,300,000.00  
Delivery Period : 45 calendar days  
Location : DOJ Padre Faura St., Ermita, Manila

The prospective bidders must have an experience of having completed, within a period of ten (10) years from date of submission and receipt of bids, at least one (1) contract similar to the contract to be bid, and whose value, adjusted to current price using NSO consumer price indices, must be at least fifty percent (50%) of the ABC to be bid. The Eligibility Check/ Screening as well as the Preliminary Examination of Bids shall use non-discretionary "pass/fail" criteria. Post-qualification of the lowest calculated bid shall be conducted.

All particulars relative to Eligibility Statement and Screening, Bid Security, Performance Security, Pre-bidding Conference, Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of the Revised Implementing Rules and Regulation (IRR) of Republic Act No. 9184 dated 28 October 2016 and GPPB Resolution No. 09-2020, dated 7 May 2020.

Prospective bidders who will opt to submit electronically must comply with the following conditions:


- 1) The bid submission must be in an archive format and password protected;
- 2) The bid submission must allow access to a password-protected Bidding Documents on the scheduled date and time of the Opening of Bids. Passwords will be disclosed by the bidders ONLY during the actual virtual bid opening;
- 3) The bid submission must be capable of generating an audit trail of transactions.

All participating bidders shall be charged the following non-refundable bid fee, to wit:

- Procurement of Renewal of Firewall and Management Appliance License for DOJ Main – P 10,000.00
- Procurement of Renewal of Firewall License for NPS NCR Offices - P 5,000.00
- Procurement of Next-Generation Firewall for DOJ Disaster Recovery Site\_- P 5,000.00
