**INVITATION TO BID**

The Department of Justice, through its Bids and Awards Committee (BAC) is inviting interested parties to bid the hereunder project:

Name of Project : Supply and Implementation of Disaster Recovery and Back-Up Solution

Location : Department of Justice, Padre Faura St. Ermita, Manila

Approved Budget for the Contract (ABC) : P8,000,000.00

Delivery Period : 45 calendar days

The prospective bidders must have an experience of having completed within a period of ten (10) years from the date of submission and receipt of bids, at least one (1) contract similar to the contract to be bid, and whose value, adjusted to current price using NSO consumer price indices, must be at least fifty percent (50%) of the ABC to be bid. The Eligibility Check/Screening as well as the Preliminary Examination of Bids shall use non-discretionary "pass/fail" criteria. Post-qualification of the lowest calculated bid shall be conducted.

All particulars relative to Eligibility Statement and Screening, Bid Security, Performance Security, Pre-bidding Conference, Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of the Revised Implementing Rules and Regulation (IRR) of Republic Act No. 9184 dated 28 October 2016.

All prospective bidders shall be charged a non-refundable bid fee in the amount of Ten Thousand Pesos (Php P10,000.00).
