RESOLUTION

**RECOMMENDING THE AWARD OF CONTRACT TO
PANTRONICS INTERNATIONAL CORPORATION FOR THE
SUPPLY, DELIVERY, AND INSTALLATION OF ONE (1) UNIT 43-INCH
LED MONITOR, ONE (1) SET VIDEO CONFERENCING ROOM SOLUTION,
AND ONE (1) SET PORTABLE VIDEO CONFERENCING EQUIPMENT**

WHEREAS, there is a need for the Department of Justice (DOJ) to procure the supply, delivery, and installation of one (1) unit 43-inch LED monitor, one (1) set video conferencing room solution, and one (1) set video conferencing equipment;

WHEREAS, the procurement of the said video conferencing equipment is included in the DOJ CY 2021 Annual Procurement Plan (APP) with an allotted budget of Three Hundred Thousand Pesos (₱ 300,000.00) and negotiated procurement as mode of procurement;

WHEREAS, the Request for Quotation (RFQ) for the aforementioned project was posted on 30 June 2021 in the DOJ and PhilGEPS websites, and in a conspicuous place in the Department continuously for six (6) calendar days;

WHEREAS, in response to the said RFQ, one (1) prospective supplier submitted its quotation, to wit,

NOW, THEREFORE, for and in consideration of the foregoing, the Bids and Awards Committee **RESOLVES**, as it hereby resolve, to **RECOMMEND** the confirmation of resort to negotiated procurement thru Small Value Procurement, and further recommend the award of contract for the supply, delivery, and installation of one (1) unit 43-inch LED monitor, one (1) set video conferencing room solution, and one (1) set video conferencing equipment to **PANTRONICS INTERNATIONAL CORPORATION**, in the amount of **TWO HUNDRED SEVENTY-FOUR THOUSAND NINE HUNDRED FIFTY PESOS (₱ 274,950.00)**, following the procedures prescribed in R.A.
