Please be informed that the award of the contract for the purchase of ICT Projects for IACAT in the total amount of **SIX HUNDRED SIXTY FIVE THOUSAND EIGHT HUNDRED NINETY PESOS AND TWENTY CENTAVOS (P665,890.20)**, is hereby given to your firm subject to your submission of a "Performance Security" to guarantee payment of security as penalty if the contractor is in default in his obligation, to be posted in favor of this Department and executed in the prescribed form and at least co-terminus with the final acceptance of the project.


The following provisions shall form part of the said security, thus: "The right to institute action on the penal bond pursuant to Act. No. 3688 of any individual firm, partnership, corporation and association supplying the contractor with labor and materials for the prosecution of the work is hereby acknowledged and confirmed".

The performance security shall be in accordance with any of the following schedule:

- a) Cash, cashier's/manager's check (payee - DOJ BAC Trust Fund), bank draft/guarantee confirmed by a Universal or Commercial Bank, irrevocable letter of credit issued by a Universal or Commercial Bank: Provided, however, that it shall be confirmed or authenticated by a Universal or Commercial Bank, if issued by a foreign bank - Five Percent (5%) of the total contract price; and
- b) Surety bond callable upon demand issued by a surety or insurance company duly certified by the Insurance Commission as authorized to issue such security - Thirty Percent (30%) of the total contract price.

**RESOLUTION RECOMMENDING THE AWARD OF CONTRACT TO
THE VALUE SYSTEMS PHILS. INC. FOR THE PURCHASE OF ICT
PROJECTS FOR IACAT**

RESOLUTION

WHEREAS, the Department of Justice (DOJ) published its Invitation to Bid/Request for Expression of Interest for the purchase of ICT Projects for IACAT in the Philippine Daily Inquirer for three days (November 20, 21 & 22, 2013), and was posted in the PhilGEPS, DOJ Website, bulletin boards of Manila City Hall and Department of Justice continuously for a minimum of seven (7) days;

WHEREAS, in response to the said invitation, only one (1) prospective bidder purchased the bid documents;

WHEREAS, in a public bidding held on December 13, 2013 at 9:30 a.m. at the conference room of the BAC Chairman, Room 313, 3rd floor DOJ Main Building, only The Value Systems Phils. Inc. submitted its bid and passed the preliminary evaluation of the bid requirements;

WHEREAS, Section 36 of the Revised Implementing Rules and Regulations of Republic Act No. 9184 provides: "A single calculated/rated and responsive bid shall be considered for if it falls under any of the following circumstances: xxx a) If after advertisement, only one prospective bidder submits an LOI and/or applies for eligibility check, in accordance with the provisions of this IRR, and it meets the eligibility requirements or criteria, after which it submit a bid which found to be responsive to the bidding requirements";

WHEREAS, after the bidding, the bid documents were referred to the Technical Working Group (TWG)/Secretariat of the Bids and Awards Committee (BAC) for post-qualification and evaluation of the bid;

WHEREAS, the Approved Budget for the Contract (ABC) under bidding is P675,590.00;

WHEREAS, the result of the evaluation by the TWG is as follows:

WHEREAS, the calculated bid of The Value Systems Phils. Inc. in the amount of P665,890.20 is 1.44% below the ABC, and was found to have post-qualified with all the legal, technical and financial requirements and, therefore, considered to be the bidder with the single calculated responsive bid;

WHEREAS, the BAC TWG/Secretariat recommends the award of the contract in favor of in its calculated bid of P665,890.20;

WHEREAS, after further evaluation of the recommendation of the BAC TWG/Secretariat to award the contract in favor of The Value Systems Phils. Inc. in the total amount of P665,890.20, the BAC finds the same to be reasonable and most advantageous to the government;

NOW, THEREFORE, the Bids and Awards Committee (BAC), after thorough deliberation, resolves to **RECOMMEND**, as it hereby recommends the award of contract to The Value Systems Phils. Inc. for the purchase of ICT Projects for IACAT in the total amount of **SIX HUNDRED SIXTY FIVE THOUSAND EIGHT HUNDRED NINETY PESOS AND TWENTY CENTAVOS (P665,890.20)**.




