Please be informed that the award of the contract for the operations capability for cyber security against child pornography or women trafficking for the Office of the Cybercrime in the total amount of **TWO MILLION FIVE HUNDRED NINETY-NINE THOUSAND PESOS (P2,599,000.00)**, is hereby given to your firm subject to your submission of the following:


“Performance Security” to guarantee payment of security as penalty if the contractor is in default in his obligation, to be posted in favor of this Department and executed in the prescribed form and at least co-terminus with the final acceptance of the project. The following provisions shall form part of the said security “The right to institute action on the penal bond pursuant to Act. No. 3688 of any individual firm, partnership, corporation and association supplying the contractor with labor and materials for the prosecution of the work is hereby acknowledged and confirmed”. The performance security shall be in accordance with any of the following schedule:

- a) Cash, cashier's/manager's check, bank draft/guarantee confirmed by a Universal or Commercial Bank, irrevocable letter of credit issued by a Universal or Commercial Bank: Provided, however, that it shall be confirmed or authenticated by a Universal or Commercial Bank, if issued by a foreign bank – Five Percent (5%) of the total contract price; and


- b) Surety bond callable upon demand issued by a surety or insurance company duly certified by the Insurance Commission as authorized to issue such security – Thirty Percent (30%) of the total contract price.

RESOLUTION

WHEREAS, the Department of Justice (DOJ) posted its Invitation to Bid for the operations capability for cyber security against child pornography or women trafficking for the Office of the Cybercrime (OOC), in the PhilGEPS, DOJ Website and Bulletin Boards of the Manila City Hall and Department of Justice, continuously for a minimum of seven (7) days;

WHEREAS, in response to the said invitation, one (1) bidder purchased and submitted its bid for the operations capability for cyber security against child pornography or women trafficking for OOC;

WHEREAS, The Value Systems Phils., Inc. (Value Systems) passed the preliminary evaluation of the bid requirements;

WHEREAS, after the bidding, the bid documents were referred to the Technical Working Group (TWG)/Secretariat of the Bids and Awards Committee (BAC) for post-qualification and evaluation of the bid;

WHEREAS, the Approved Budget for the Contract (ABC) for the subject bidding is P2,600,000.00;

WHEREAS, the result of the evaluation by the TWG is as follows:

WHEREAS, the calculated bid of Value Systems in the amount of P2,599,000.00 is 0.04% below the ABC, and that its documents are found to have post-qualified with all the legal, technical and financial requirements and, therefore, considered to have submitted a single calculated responsive bid;

WHEREAS, the BAC TWG/Secretariat recommends the award of the contract in favor of Value Systems in its calculated bid of P2,599,000.00;

WHEREAS, after further evaluation of the recommendation of the BAC TWG/Secretariat in favor of Value Systems in the total amount of

P2,599,000.00, the BAC finds the same to be reasonable and most advantageous to the government;

NOW, THEREFORE, the Bids and Awards Committee (BAC), after thorough deliberation, resolves, as it hereby resolves to **RECOMMEND** the award of contract for the operations capability for cyber security against child pornography or women trafficking for Office of the Cybercrime (OOC) in favor of The Value Systems Phils., Inc. in the total amount of **TWO MILLION FIVE HUNDRED NINETY-NINE THOUSAND PESOS (P2,599,000.00)**.


